#### Introduction

The purpose of this Assessment is to gather preliminary information related to local Anti-Corruption efforts, and to assess potential legal and regulatory risks in each location. Each Assessment worksheet (TAB) should be completed by the employee deemed the most knowledgeable in respect to each area. The worksheets should be disseminated directly by the Barrick in-house counsel assigned to oversee the assessment. When the worksheets are completed, they should be returned directly to the attorney who provided it. The attorney assigned to oversee the assessment should document the individuals who assisted in responding to the questions from each area. A copy of the completed Assessment should be maintained by the country Legal department, sent to the Office of the General Counsel (OGC) in Toronto, and posted on Sharepoint. The information provided in each worksheet will be assessed by the OGC, country in-house counsel, and potentially outside counsel, and may require additional follow up.

This Assessment is directed by counsel, and is privileged and confidential. The information is being generated to assist in identifying legal risks, including and in respect to investigatory efforts.
